

## **A Statement From Chairman Abie Moses on The Organization for Victims of Terrorism in Israel**

October 2023

### **About**

The Organization for Victims of Terrorism in Israel is a non-profit association created for thousands of civilians who have been recognized by the state of Israel as victims of terrorist or military attacks. These victims include widows, orphans, and disabled people.

The organization has been active since 1984, supporting thousands of victims of terrorism. In 1998 it was designated as the official representative organization by the Israeli parliament (the Knesset) and Ministry of Welfare and Social Affairs of Israel. It maintains the largest databank of terrorism victims in Israel.

It is the organization in Israel that is responsible for all civilian casualties.

### **The Hamas Attack and Our Work**

On October 7th, 2023, the Hamas attack in the south created thousands of new civilian casualties. Among the casualties are individuals who lost their lives or loved ones in atrocious and inhumane ways. There are the wounded and survivors living in fear, children suffering from nightmares, families grieving over their losses – their lives seem hopeless and full of despair.

We ask you to help and become involved in the recovery and healing process that these families desperately need.

Our organization's purpose is to tend to the immediate welfare of these victims while guiding them through recovery. The victims' needs will be addressed by us and we will make every effort to help them with all of their essential needs. Over the long run, we aspire to provide the families with the necessary tools that will allow them to address their pain and trauma in the hope this will allow them to overcome these difficulties and live more satisfying lives.

## Funding and Donors

In the name of the organization and on behalf of the families we turn to you for help by making out a donation and providing the financial means to aid these people in distress who need immediate attention and assistance.

On behalf of The Organization for Victims of Terrorism in Israel, we ask you to become our partners.

Your donation will be used for the rehabilitation of the victims' families:

- Financial aid for the families who are still mourning their loved ones.
- Humanitarian assistance to the victims, including the collection and transportation of basic equipment (clothing, toiletries, etc.) and food supplies.

The Organization for Victims of Terrorism in Israel is recognized as a public institution, a non-profit organization under section # 46 of the Israeli Income Tax Act. A donation to this organization may be considered as a tax deductible in certain jurisdictions.
